No.GG/63/2019/VDR/10-2017/654/E.1:- In exercise of the powers conferred by section 8 of the Gujarat Prohibition Act, 1949 (Bom. XXV of 1949) read with sub-rule (1) of rule 65 of the Bombay Foreign Liquor Rules, 1953 and in supersession of all the notifications issued in this behalf, the Government of Gujarat hereby,-

- (i) constitutes the Medical Board (hereinafter referred to as the "Area Medical Board") as specified in column (2) of the Schedule annexed hereto for the areas specified against them in column (4) of the said Schedule and directs that each of the Area Medical Boards shall consist of the Members specified against it in column (3) of the said Schedule; and
- (ii) appoints the places specified in column (5) of the said Schedule to be the place of sitting for the respective Area Medical Boards.


